IPM Construction & Development Corp.	Requested that the submission of bid be moved to April 5, 2019 to give ample time to prepare a complete, reliable and competitive bid.	Request has been denied.
Davao Rock Mixer Enterprises	What is the similar completed Project? There is no such contractor who have been awarded with the similar Project. This is a landfill and will develop the area. It will be a land development project , the similar project shall include roads, building sanitary, flood control and etc.	The description of an eligible bidder is contained in the Bidding Documents, particularly in Clause- 5.4 of Section II. Instructions to Bidders. For purposes of this project, similar contracts shall refer to the contracts involving Design and Construction of Sanitary Landfills. We have noted your concern; however, DENR-EMB confirmed that there are Sanitary Landfills operating Nationwide.
Davao Rock Mixer Enterprises	What is the required PCAB category and ARCC for this project?	The required PCAB Classification and Category for this project is GENERAL BUILDING GB -4. The ARCC is Medium B Category A. This was based on the PCAB Categorization – Classification Table (Board Resolution No. 201, series of 2017)

If there is, could we get a template of it?	<p>The provided BOQ in the Bidding Documents is for bidder's reference which contains the minimum required items and could be used as guide in the preparation of the proposed BOQ. The contract is for the design and build, and the bidders are not limited with the specified minimum scope of works set by the end-user. Please be guided with the IRR 2016 of the RA 9184.</p> <p>The Bid Price Form shall be used as provided in the Bidding Document Sec. IX "Bid Form - Annex A".</p>
