Evaluation of sample/demo unit during post-qualification stage shall be conducted by the BAC, through the Joint PS - DOH TWG. Bidder shall provide all consumables and tools necessary for the testing of equipment.

Request/s for extension of submission of samples may only be allowed under the following circumstances:

a.) That the sample/s to be submitted is/are imported; and

The failure to comply with the original deadline of submission is accompanied by good faith i.e., there must be proof/s that importation had commenced prior to the original deadline of submission and the delay on the importation was due to circumstances beyond the control of the bidder.
