In the latter case, the bidder shall submit a valid and updated PhilGEPS Registration Certificate including its Annex "A" as part of post-qualification documents.

To amend the requirement on the submission of Valid and Current Tax Clearance during opening of bids. In lieu of the submission of the Tax Clearance a certificate attesting to full payment or any verifiable proof of payment of all taxes from BIR is acceptable but the Tax Clearance Certificate will be submitted during Post Qualification.
