However, we checked over <u>http://www.cordura.com</u> and it clearly shows in the website that the CORDURA® fabric is a brand and not a type of fabric. Therefore, we are requesting your consideration for the material/s to be used for the body bag should not be brand- specific.	The requirement is retained.
