However, we checked over <a href="http://www.cordura.com">http://www.cordura.com</a> and it clearly shows in the website that the CORDURA® fabric is a brand and not a type of fabric. Therefore, we are requesting your consideration for the material/s to be used for the body bag should not be brand-specific.</p>	The requirement is retained.
