The Provisional Member reminded the bidders that prices must be thoroughly checked for consistency as there are cases that the Total Lot Bid Price is in consistent with the TOTAL LOT BID PRICE IN WORDS.

Annex No. C Page No. 108

The Provisional Member emphasized on the importance of the Omnibus Sworn Statement and reminded bidders of the Rule of Notarial Practice, that Community Tax Certificates (CTC) not acceptable competent evidence of identity and will be a ground for ineligibility.

The Provisional Member reminded bidders on the required contact information; that it must be updated and bidders must actively check their declared email addresses for Notices issued by the BAC as the reckoning period for the said notices is the date transmitted by the BAC.

Annex No. M Page No. 125

The Provisional Member explained the proper procedure in accomplishing the said form, reminded bidders to divulge all ongoing contracts in order to properly validate the declared NFCC. Otherwise, it will be a ground for Ineligibility and subsequent Blacklisting.

The Provisional Member reminded the bidders not to leave any blanks on Annex "C" and "C-1" and encouraged bidders to simply indicate "Not Applicable" or "N/A" in the said form if there are no details to be filled out.

Annex No. I Page No. 120

The Provisional Member presented the 3rd form of Bid Security, explaining to the bidders on the proper procedure in accomplishing the said form and reminded bidders to thoroughly examine the contents of the said of the document.

The Provisional Member reminded the bidders that the said form will be signed the authorized representative and notarized, further explaining that CTC is not acceptable as explained earlier with the Omnibus Sworn Statement.

Annex No. J-K Page No. 122- 123

The Provisional Member instructed bidders to properly accomplished the said form and not to miss out any details and may be a ground for the

disqualification during the evaluation of their bid.

Annex No. N Page No. 126

The Provisional Member explained the proper instructions in filling up the said form and its use in evaluating the key personnel for the contract in terms of the work experience.

II. OTHER DISCUSSIONS

The Secretariat presented a promotional video that highlights the procurement projects under R.A. 9184.

The Chairperson highlighted that the video presented is for general infrastructure projects and that the project at hand is a design and build infrastructure project which involves a 2 stage bidding process.

Asiaphil, Inc./ PhilCantech asked the BAC if they can use the certificate of inspection issued to them on the previous bidding.

The Chairperson answered in affirmative and informed that the bidders can withdraw their submitted bids.

The Provisional Member presented the Annex "G" of R.A. 9184 as an additional reference to bidders for design and build projects.

OTHER MATTERS

Philcantech asked what will be the grounds for disqualification for the conceptual designs and construction methods.

Chairperson advised that questions will be answered after the presentation of the technical specifications.

The Provisional Member emphasized on the No-Contact Rule that prohibits bidders to make any communication about their respective bids.

The representative from MN Electro requested for a two (2) week extension for the deadline of submission of bids.

The BAC took note of the request, and asked other bidders if they share the same request as MN Electro.

Representatives from Philcantech, AN Escalante and Fambik signified their

	agreement with the request; being Asiaphil the only bidder that didn't request for an extension.
