_	- The Vice-Chairperson emphasized that the ABC were based on	

 latest market survey conducted and approved by the OED. However, he encouraged LMS to email their concerns to properly endorse the same to Technical Specifications Review Committee (TSRC). The Committee presented the TSRC's recommendations to amend the existing Packaging and Marking and Labelling requirement in the technical specifications of all PS Common-use Supplies and Equipment (PS-CSE). It was approved by OED on 11/20/2019. However, said amendment will take effect on those items that has no approved ABC yet or still under market survey.
