1 The Government of the Republic of the Philippines has applied for financing from the Asian Development Bank (ADB) toward the cost of the Malolos – Clark Railway Project. Part of this financing will be used for payments under the Contract cited below. Bidding is open to qualified Bidders from eligible source countries of ADB.

2 The Department of Transportation (DOTr) as the Employer, through its Procuring A gent, Procurement Service Department of Budget Management (PS-DBM), now invites sealed





Bids from eligible Bidders for the construction and completion of the Works as broadly described above.

3 Bidders may bid for a single Package only, or for any combination of Packages.

Pursuant to ITB 35.4, the Employer shall evaluate and compare Bids on the basis of a single Package, or a combination of Packages, or as a total of Packages in order to arrive at the least-cost combination for the Employer, by taking into account discounts offered by Bidders in case of award of multiple contracts.

Discounts for multiple contracts however, may only be offered by Bidders in the case of two or more of Packages 1, 2 and 3 being combined.

In accordance with ITB 14.4, any Discount offered by Bidders in the above cases and the methodology for its application, shall be stated under item (d) in the Letter of Bid.

The Employers evaluation shall include an assessment of the Bidders capacity to meet the following aggregated requirements as presented in the Bid. Bidders' key qualifications are summarised in the Table below:
