1. The *Procurement Service*, through the *General Appropriations Act (SAA# 2016-03-0296 and SAA# 2017-06-1107)* intends to apply the sum of *Twenty Five Million Pesos (Php 25,000,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the Design and Build for the Renovation of Pototan Mental Health Unit for the Western Visayas Medical Center. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Procurement Service* now invites bids for:

Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the *Procurement Service* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00PM.
