DECLARATION OF BID AS RESPONSIVE AND RECOMMENDING AWARD OF CONTRACT Resolution No. BAC1-2019-07-01

WHEREAS, the Procurement Service advertised and posted calls for tender Supply and Delivery of Stapler, Standard Type (PB No. 19-182-1) with total Approved Budget for the Contract (ABC) of Seventeen Million Five Hundred Ninety Seven Thousand Three Hundred Eighty pesos (Php 17,597,380.00) consisting of one (1) lot, consistent with the provisions of the revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, bid proposal was submitted by the lone bidder (Center Point Sales and Trading Inc.) and immediately opened on June 25, 2018 (see attached Abstract of Bids as Read for the results of opening);

WHEREAS, the bid proposal of Center Point Sales and Trading Inc., details of which is provided below, was determined to be the Single Calculated Bid (SCB) pursuant to Rule IX of the IRR of RA No. 9184, and subjected to post-qualification;

WHEREAS, the TWG proceeded with its post-qualification of the bid of Center Point Sales and Trading Inc;

WHEREAS, pursuant to Sec. 34.4 of Republic Act No. 9184, "If the BAC determines that the bidder with the Single Calculated Bid/Highest Rated Bid passes all the criteria for postqualification, it shall declare the said bid as the SCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower.
