DECLARATION OF BID AS RESPONSIVE AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Procurement Service advertised and posted calls for tender for the **Supply, Delivery, Testing, Installation, Commissioning and Training of Back-up Data System for Philippine Army (PB No. 19-143-1)** with total approved budget of **Seven Million Eighty Seven Thousand One Hundred Forty Nine pesos (Php 7,087,149.00)** consisting of 1 item, consistent with the provisions of the revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, bid proposals were submitted by the following bidders and immediately opened on May 28, 2019 (*see attached Abstract of Bids as Read for the results of opening*);

WHEREAS, the bid proposal of **Macrologic Diversified Technologies**, details of which are provided below, was determined to be the **Lowest Calculated Bid (LCB)** pursuant to Rule IX of the IRR of RA No. 9184, and subjected to post-qualification;

WHEREAS, the TWG proceeded with its post-qualification of the bid of **Macrologic Diversified Technologies**,

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted, the bid was found to be non-responsive. The latter was post-disqualified through the Notice of Post-Disqualification (NPDQ) dated July 01, 2019; that no request for reconsideration was submitted by Macrologic Diversified;

WHEREAS, the bid proposal of **Infocentric Solution Inc.**, details of which are provided below, was determined to be the Second Lowest Calculated Bid pursuant to Rule IX of the IRR of RA No. 9184, and was subjected to post-qualification:

WHEREAS, pursuant to Sec. 34.4 of Republic Act No. 9184, "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower.
