NOTICE TO THE BIDDERS

This has reference to the recently conducted Opening of Bids for the Supply and Delivery of School Furniture for Elementary and Secondary Schools Nationwide under the 10% Allocation for Cooperatives of Persons with Disability (PWD) for the Department of Education (DepEd) under Public Bidding Reference No. 20-007-8.

WHEREAS, the proposals of the following bidders were declared "Eligible" and therefore subject to Bid Evaluation and Post Qualification:

- i. San Francisco Association of Differently Abled Person Multi-Purpose Cooperative (SAFRA-ADAP MPC);
- ii. Alliance of Isabela Disabled Persons Development Cooperative (AIDPDC); and
- iii. Handicapped Persons Producers Cooperative (HAPPC)

WHEREAS, the Philippines was placed under a state of Public Health Emergency upon confirmation of local transmission of the Corona Virus Disease (Covid-19) through Presidential Proclamation No. 922 issued on 08 March 2020;

WHEREAS, Section 2 thereof states that: "All government agencies are enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat.";

WHEREAS, the Bids and Awards Committee VIII put into consideration the health condition of the eligible bidders for the project: Persons With Disability (PWDs) which are prone to the transmission of the disease.

Considering the condition of the bidders and in connection with the declaration of the Enhanced Community Quarantine (ECQ) of the President of the Republic, the issuance of the Lowest Calculated Bid together with the submission of Post Qualification Documents and samples will be postponed until further notice.
