Milestone Payment Schedule

The Contractor is required to duly accomplish **Tables 1 to 3** and sign all pages of this document and submit, within ten (10) calendar days upon receipt of Notice of Award, the duly accomplished and signed Milestone Payment Schedule as part of the Contract and basis for payment. [Ref: 31.4(f) of BDS].

1 COST CENTERS

The Works shall be divided into the following Cost Centers named according to the general scope of work. The Cost Centers represent the major items of the Works for which the Procuring Entity will pay the Contractor, and the Contractor shall ensure that it has allowed for all the costs that it requires for the Contract to meet the Procuring Entity's Requirements.

- · Cost Center A DESIGN PHASE 15%
- Cost Center B EARTHWORKS, DEMOLITION WORKS and CIVIL WORKS - 20%
- Cost Center C MASONRY WORKS, STEEL WORKS and ROOF FRAMING and ROOFINGS (including Gutter, Fascia Board and Parapet)
 - 30%
- Cost Center D CARPENTRY WORKS, FINISHING WORKS, RAILINGS and DOORS AND WINDOWS - 20%
- Cost Center E GENERAL REQUIREMENTS, PAINTING WORKS, PLUMBING WORKS and ELECTRICAL WORKS - 15%

2 MILESTONES

2.1 The Contractor shall divide the Cost Centers into Milestones. The Milestones under each Cost Center represent the completion of verifiable activities to be undertaken by the Contractor towards the completion of the work within that Cost Center.

- 2.2 Key Dates for each stage of work (See Table 1, Clause 1.8, Annex 1 to Section VI) are the periods by which certain stages of work and all the required milestones of that particular stage are to be completed. The Contractor is informed that these dates are to be determined by reference to periods from the Commencement Date of the Works. Milestone dates shall be likewise determined by reference to the respective periods from the Commencement Date of the Works. It is the intention that, prior to Commencement Date, the Intended Completion Dates and Milestones shall be converted to calendar dates. For certain Dates, non-completion of relevant stages of work and all the required milestones within the corresponding Dates shall entail liquidated damages as laid down in GCC Clause 9.
- 2.3 Milestones that lead to the achievement of a Stage must always precede the Intended Completion Date for achievement of that Stage. Milestones shall be converted to calendar dates upon issuance of the Notice to Proceed.
- 2.4 The scope and extent of the Works are to be ascertained by reference to the Contract Documents as a whole and shall not be limited in any manner whatsoever by the descriptions of the Cost Centers or the Milestones under each Cost Center.
- 2.5 Cost Centers are fixed and shall not be changed by the Contractor. The Contractor, however, may add additional Milestones in a Cost Center provided such Milestones genuinely relate to said Cost Center activities and subject to review by the Procuring Entity's Representative and concurrence by the Procuring Entity.
- 2.6 If, during the course of contract execution, it becomes necessary to add Milestones in a Cost Center, the Lump Sum Amount of the Cost Center which will remain unaltered, will be reapportioned among the Milestones (including the proposed new milestones), in the subject Cost Center. The liability of the Procuring Entity will be limited to the fixed Lump Sum Amount already accepted by the Procuring Entity and the Contractor will have no right to claim anything over and above the fixed Lump Sum Amount brought about by said addition of Milestones in a Cost Center. The decision of the Procuring Entity shall be final and binding in such matters and shall not be subject to conciliation or arbitration.

3 MILESTONE PAYMENTS

- 3.1 The Total Contract Amount for the whole of the Works shall be summed up from the total of the amounts quoted among the various Milestones and Cost Centers. The Amount of Pesos quoted against each milestone shall include the amount of VAT The Contractor shall quote prices for all the Milestones. If the Contractor quotes a "zero" value for any of the Milestones, it shall explain in which other Milestone the amount of the same is covered.
- 3.2 The sum total of the amounts shown against the Milestones in a Cost Center is the Cost Center Total, which shall be carried forward to the Cost Centers Summary. The Total

Cost Center Summary shall be carried forward to the Total Contract Amount. The Total Contract Amount contained in this Milestone Payment Schedule shall exactly be the same as the Contract Amount (inclusive of 12% VAT) specified in the Notice of Award.

- 3.3 The amount quoted for each Milestone and Cost Center should have relation to the content of work involved in each Milestone and Cost Center. If abnormal variations are found in the amount quoted for any of the Milestones under the Cost Centers compared to the estimate of the Procuring Entity's Representative, the same may be pointed out, before signing of the Contract, and the price of such milestones shall be modified by redistributing the Total Contract Amount, which shall be unchanged.
- 3.4 The first application for interim payment (not applicable for Advance Payment) may be made only after a lapse of a full calendar month from Commencement Date.
- 3.5 Unless otherwise specified, agreed and approved, Milestone payments shall be released only after the full completion of the total work described in the Milestone and no partial payment shall be released for any Milestone.
