SUPPLY AND DELIVERY OF VARIOUS OFFICE SUPPLIES FOR THE PROCUREMENT SERVICE

Issued pursuant to Sec. 22.5 of the IRR of R.A. 9184 to clarify and/or amend certain provisions in the Bidding Documents issued for this project, considering the issues raised and clarifications made by prospective bidders during the Pre-bid Conference held on **December 22, 2020.**

A. Clarifications

1.	The bidder asked about the percentage of having a domestic bidder preference certificate.	Letter of Clarification from Timco Manufacturing Corporation	Yes, we will allow the submission of Domestic Preference Certificate per ITB Clause No. 18.1 of the Bidding Documents. Provided that the sample/s submitted shall be consistent with the issued valid certificate/s.
2.	The bidder asked about the transition from testing up to the awarding of the Notice of Award.	Letter of Clarification from Timco Manufacturing Corporation	Upon issuance of Notice of Lowest Calculated Bid (NLCB), we will issue Evaluation of Samples /Post-Qualification within five (5) calendar days. Notice of Award may be issued within seven (7) calendar days. This taking into consideration that no Request for Reconsideration/Protest received.
3.	The bidder raised during Pre-Bid Conference the clarification on Mayor's Permit requirement.	Section III BDS Clause 20.2 Page No. 24	The Mayor's Permit should be valid during the Opening of Bids. For purposes of post-qualification, the bidders need to submit the previous year Mayor's Permit and proof of renewal. However, before the release of first payment, the PhilGEPS Certificate of Platinum Membership with updated Annex A must be submitted.

4.	The bidder requested to extend the number of years of SLCC from five (5) years to ten (10) years.	BDS Clause 5.3	The requirement is retained.
