The same is applicable for the NFCC. <i>Provided</i>, on both accounts, that the SLCC and the NFCC complies with the requirements reflected in the Bidding Documents. Bidders are reminded, further, that all partners of the JV are required to submit PhilGEPS Certificate, Latest Income Tax Returns for year 2018 (BIR Form 1701 or 1702), AFS and Latest Value Added Tax Returns (Form 2550M and 2550Q) or Percentage Tax Returns (Form 2551M) covering the last six months; All of which shall be used to validate the NFCC.</p>
