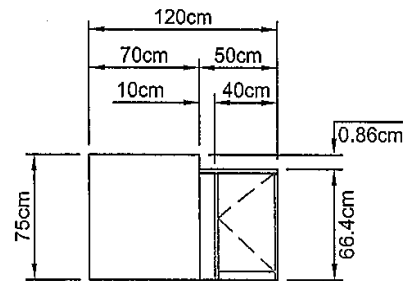

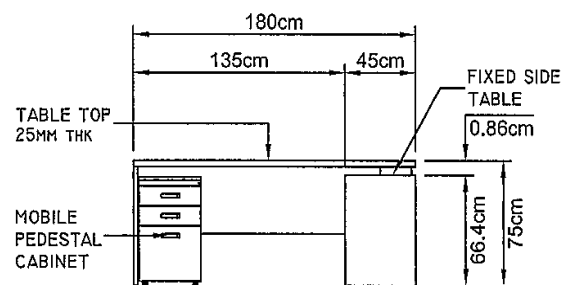

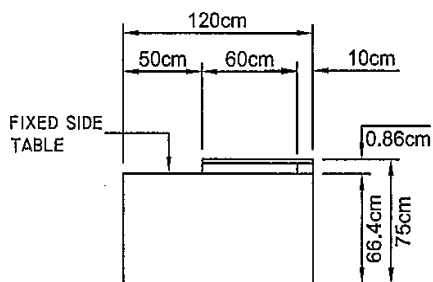
RIGHT SIDE ELEVATION



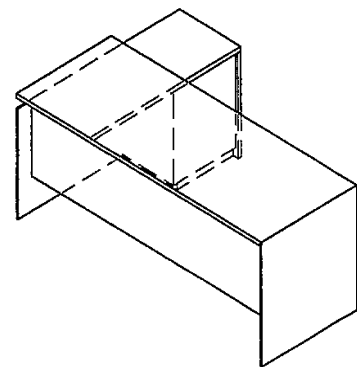
FRONT VIEW

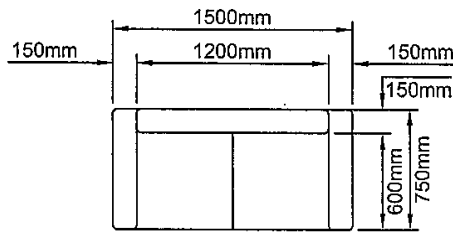

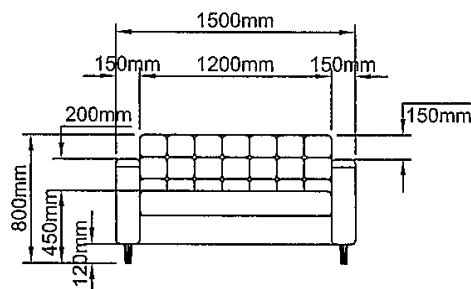

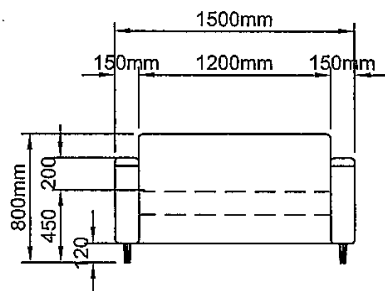

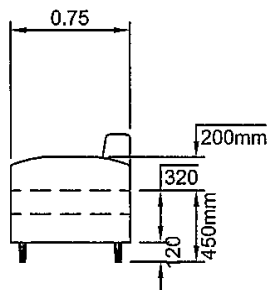

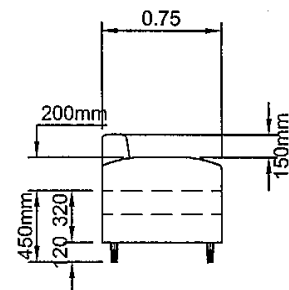
FRONT ELEVATION
