- The name and logo of the Procurement Service
- The address and contact details of the Procurement Service
- A statement which states that the item is "Government-Use Only"
- Procured by Procurement Service DBM

To reflect the updated requirement on the Packaging.

Additional requirement on packaging and marking/labeling, the sticker will be place on all sides of the box.

- The size of the logo must be manufacturer's standard provided that:
  - It must be placed in visible areas of the box;
  - Stocking position must also be considered in placing the stickers; and
  - <u>Size must be large enough to be seen and recognized from short distance.</u>
