Therefore, it is much safer to have TWO HOSE REELS INSTEAD, ONE ON EACH SIDE because any malfunction or wrong operation will not cause any problems because the pressure remains in the hose at the hose reel."

Furthermore, you have to know that due to the friction loss inside a 25mm hose the output of the water/foam nozzle will be less than 120 lpm. Using 32mm/30m hose will give you an output of at least 220 lpm. Same applies for the DCP hose reel as well. Here we recommend to use also a 32mm/30 hose to achieve the required output. At least this alternative shall be allowed in this procurement, which is either ONE DUAL AGENT HOSE REEL OR TWO SEPARATE HOSE REELS FOR WATER AND FOAM WITH 32MM/30M."
