

On drawing sheet P 29. 1-1 shows the plan of 350 cu.m. Cistern Tank. The tank dimension is 10000mm x 15000mm. The tank piping have the following:


- a) 2 nos. x 150 mm diameter gate valve supply lines in a valve box on the right side.
- b) 2 nos. x 150 mm diameter gate valve supply lines and 2 nos. x 150 mm diameter gate valve distribution lines in a valve box on the left side, in total there 4 nos. valve box on the left side.

As shown, the valve box is not proportionally/scaled drawn either the smaller or larger valve box, Hence, please clarify which details to follow taking into consideration the dimension of the tank is 15m only but will have 4 nos. valve box to be constructed.



For 75 mm and SMALLER valves, please refer to the valve box details below:

#### 350 cu.m. Cistern Tank

- a. There are two (2) supply lines (from deep well source) with 150mm gate valves inside the valve box at the right side leading to the two compartments/chambers of the 350 cu.m. cistern tank.
- b. There are four (4) 150mm gate valves inside the valve box at the left side for the following:
