SUPPLY AND DELIVERY OF NOTEPAD, STICK-ON
FOR THE PROCUREMENT SERVICE (PS)

Issued pursuant to Sec. 22.5 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 to clarify and/or amend certain provisions in the Bidding Documents issued for this project, considering the issues raised and clarifications made by prospective bidders during the **Pre-Bid Conference** held on **29 August 2023**.
