1	A prospective bidder clarified that upon checking with DOST - FOREST PRODUCTS RESEARCH AND DEVELOPMENT INSTITUTE (FPRDI) they will not be able to TEST the BRIGHTNESS (ISO) of the paper towel. However the manufacturer can do testing of brightness.	Section VII. Technical Specifications	The committee hereby clarifies that under Section III. Bid Data Sheet Clause 20.2 that the sequence of the acceptable test result must be issued by Government Laboratory Testing Center or Government Accredited Laboratory Testing Center or Third party Laboratory Testing Center. In cases where required parameters were not all tested due to no fault of the bidder, the certificate may be accepted provided that proof of non-availability from the testing center shall be submitted during post-qualification <u>together with the test result from any available testing center.</u>

Additional to the requirement.

The herein amendments form an integral part of the bidding documents. Correspondingly, all other provisions in the bidding documents affected by these amendments are similarly amended or modified.

The clarifications made explain in greater detail the purpose or intent of the requirement and do not necessarily amend that particular provision in the bidding documents.
