Issued pursuant to Sec. 22.5 of the IRR of R.A. 9184 to clarify and/or amend certain provisions in the Bidding Documents issued for this project, considering the issues raised and clarifications made by prospective bidders during the **Pre-Bid Conference** held on **27 November 2024**, likewise, response to bidders' written queries received within the prescriptive period for filing.

testing, not marker
performance.

They also attached Annex B, which contains the testing method for all types markers of provided by Bureau Veritas, referencing the international testing standard JIS S 6037: 2006 (JWIMA/JSA).

All of the information above, it appears that the required testing outlined in the bidding documents not has been conducted, as no one currently performs this specific test for markers.
