Their concern arises from the fact that our bidding is scheduled for January 2 and 6, 2025, for the supply of sign pens and permanent markers in all colors. Given that the renewal process at the Local Government Unit (LGU) will resume only in the second week of January 2025, we would like to clarify whether we can still use our expired Mayor's Permit on PhilGEPS for this particular bidding event.

Bidders shall only submit a valid and updated PhilGEPS Certificate of Registration and Membership for this project.

By Rules, all other related provisions in the Bidding Documents correspondingly affected by these amendments are likewise deemed amended to conform to this Bid Bulletin.
