1.	Prospective bidder asked if may be allowed to submit an official receipt evidencing renewal of mayor's permit in lieu of the current year's mayor's permit. The bidders contend that they could not possibly have renewed their mayor's permit at the start of the year since the renewal period starts only in January and usually takes several weeks before it is released.	The BAC hereby clarifies that a recently expired Mayor's Permit together with the official receipt as proof of application for renewal by the concerned local government unit shall be acceptable by the PhilGEPS for the purpose of updating the PhilGEPS Certificate of Registration and Membership (pursuant to GPPB Resolution No. 15-2021). Bidders shall, therefore, submit only a valid and updated PhilGEPS

		Certificate of Registration and Membership for this project.
