## 2. HEALTH AND SAFETY PROTOCOLS

In line with the IATF Guidelines on Covid19 health protocols, the Philippine National Railways (PNR) and all attendees in the subject procurement activity are required to strictly observe the following health and safety measures:

- a. For the bidder, a **maximum of three (3)** representatives/attendeesper organization;
- b. Mandatory wearing of face mask and face shields.
- c. Thebidder/representative must present a medical certificate with negative RT-PCR result valid three (3) days prior to the opening of bids.
- d. Mandatory physical and social distancing and minimum contact within the premises of Philippine National Railways (PNR).
- e. Mandatory contactless temperature check, use of foot baths and sanitation stations. A temperature of 37.5°C and above shall not be allowed to enter the premises.
- f. The bidder/representative is required to accomplish the Visitor's Pass Application Form<sup>1</sup>, which shall be presented to the PNR Security personnel upon entering the premises.

Bidder/Representative experiencing symptoms consistent with COVID-19 (i.e., fever, cough, and difficulty in breathing, among others) are advised not to attend the Opening of Bids.

- g. Mandatory use of seat signage and floor markers in the designated waiting area and Conference Room.
- h. Minimize handling of shared objects. Everyone is expected to bring their own pen for purposes of filling out and signing forms.

- j. Support staff of the Bids and Awards Committee (BAC) will be available to provide assistance during the scheduled activity.

- 4. The holder shall ensure provision of appropriate personal protective equipment (PPEs) to the attendees, if necessaty;
- 5. The holder shall comply with the vital check and COVID-19 symptoms check stated in PNR Office Order No. 32, Series of 2020, at their own expense;
- 6. The holder shall strictly comply with social and physical distancing within the work area, as much as possible;
- 7. The holder shall comply with the mandatory wearing of face mask and abide by the "No Mask, No Entry" Rule; and
- 8. This Visitor's Pass is not transferrable.
