#### **2. HEALTH AND SAFETY PROTOCOLS**

In line with the IATF Guidelines on Covid19 health protocols, the Procurement Service-DBM (PS-DBM) and all attendees in the subject procurement activity are required to strictly observe the following health and safety measures:

- a. For the participating bidder, a maximum of two (2) representatives/attendees per bid tender shall be physically allowed to attend the proceedings;
- b. Mandatory wearing of face masks and face shields.
- c. Mandatory accomplishment of the Contact Tracing Information Form and registration in PS Logbook for Guests.
- d. The bidder/representatives attending physically must present a medical certificate with a negative RT-PCR result valid within three (3) days prior to the opening of bids.
- e. Mandatory physical and social distancing and minimum contact within the premises of PS.
- f. Mandatory contactless temperature check, use of foot baths and sanitation stations. A temperature of 37.5°C and above shall not be allowed to enter the premises.

- g. Bidder/Representatives experiencing symptoms consistent with COVID-19 (i.e., fever, cough, and difficulty in breathing, among others) are advised not to attend the Opening of Bids.
- h. Mandatory use of seat signage and floor markers in the designated waiting area and Conference Room.
- i. Minimize handling of shared objects. Everyone is expected to bring their own pen for purposes of filling out and signing forms.
- j. Regular sanitation and disinfection of all facilities and equipment in PS.
- k. Support staff of the Bids and Awards Committee (BAC) will be available to provide assistance during the scheduled activity.
