- The Chairperson instructed the TWG to proceed with the discussion of the bidding documents to the prospective bidder since they are already familiar with the general requirements of government procurement. He also reminded the prospective bidders that they could interrupt during discussion for their queries or clarifications.

6. Proof of Concept (POC)

The Regular member clarified if this requirement is a document or a presentation.

As per TWG, the requirement is to submit an undertaking or to provide a demo unit for actual testing at the Bureau of Immigration main office. Undertaking would certify that the demo unit will be made available when a specific schedule for actual testing has been advised.

The Vice-Chairperson advised to include the submission of demo units in the Section VI. Schedule of Requirements and not in BDS Clause 29.22 since such clause are exclusive only for documentary requirements.

11. Compliance to ISO & ICAO Standard

The Regular member and Vice Chairperson required to provide a specific number of ISO and ICAO standard.

Response by the End-User: The offer unit must be compliant to ISO 14443.

B. Section VI. Schedule of Requirements

- The Value Systems Phils. Inc. requested to extend the delivery period from thirty to forty five (45) calendar days from the date indicated in the Notice to Proceed.

- Dermanlog asked the delivery address of the item.

Response by the End-user: The item would be delivered at the Bureau of Immigration Main Office.
