CALL TO ORDER	2.	The Chairperson acknowledged the presence of the attendees.
	3.	Having established the required quorum, the BAC Secretariat proceeded with the discussion of the documentary requirements.

DOCUMENTATIONS	 The BAC Secretariat presented the general requirements for government procurement of consulting services. During the discussion, the following topics were tackled: the purpose of the Prebid Conference, who can participate, proofs of bidder's eligibility, suggested forms, sequencing of documents, marking and packaging suggestions and the BAC X contact details, among others. 	
	SECTION II ITB Clause 12 (a) (i) Page 18-19	
INSTRUCTION TO BIDDERS	PHILGEPS Certificate of Registration and Membership in accordance with Section 8.5.2 of the IRR, except for foreign bidders participating in the procurement by a Philippine Foreign Service Office or Post, which shall submit their eligibility documents under Section 24.1 of the IRR, provided, that the winning Consultant shall register with PHILGEPS in accordance with Section 37.1.4 of the IRR	
	 The BAC Secretariat emphasized that the PHILGEPS PLATINUM registration to be submitted shall be up to date together with its contents. She gave pointers to the prospective Bidders in order for them to be guided in accomplishing each form. She also added, if any of the submitted documents in the Philgeps Registration is/are not updated the bidder's should submit the long form together with the Philgeps registration). She emphasized also for the renewal of Mayor's permits it shall attached the proof of renewal such as the Official Receipt.

• The BAC Secretariat stated the corresponding definitive computations of the SLCC would be the 50% of the ABC Php 6,073,400,00.

NFCC computation in accordance with ITB Clause 5.5 or a committed Line of Credit from a universal or commercial bank

 The BAC Secretariat elaborated on and presented the form and the formula for this particular clause.

If applicable, the Joint Venture Agreement (JVA) in case the joint venture is already in existence, or duly notarized statements from all the potential joint venture partners in accordance with Section 23.1(b) of the IRR.

• The BAC Secretariat explained to the bidders the percentage of a sixty (60%) percent for domestic entity and forty (40%) percent for foreign entity if ever they will join the Joint Venture Agreement. She presented "Annex E" of the Bidding Forms.

TECHNICAL SPECIFICATIONS	 SECTION VII Page 72-77 The TWG Member discussed the Technical Specifications and reminded the prospective bidder to write the word "COMPLY/COMPLIED" in the bidder's Statement of Compliance with corresponding reference. The prospective bidder acknowledged the reminder. The prospective bidder asked if how many horse power (HP) needed for the Submersible Pump? The End-User answered no definite horse power as long it is compatible with the submersible pump. The prospective bidder asked if there is a color scheme on Solar Powered Container House. The End-User answered there is no specific color scheme for the container house. 			
BIDDING FORMS	The BAC Secretariat presented the Bid Forms to the End-User and prospective bidder. She reminded them to write all the necessary details and the signature of authorized representative. The TWG Member also elaborated and gave some pointers to the prospective bidder in accomplishing each form.
