SCHEDULE OF REQUIREMENT	<ul> <li>A bidder clarifies the number of days for the delivery;</li> <li>The PMO-in-Charge confirmed the sixty (60) calendar days requirement;</li> <li>A bidder clarifies the place of delivery;</li> <li>PMO-in-Charge clarified the place of delivery, shall be at Palo, Leyte</li> </ul>		

#### Section VII

- PMO-in-Charge state that during the post qualification, 2 demo unit is required;
- A bidder clarified where to bring the demo unit;
- The PMO-in-Charge responded that they may submit or conduct demonstration of the demo unit to the supplier's warehouse, or at the Procurement Service, or UP Manila;
- However the Chairperson clarified the requirement, that it is mandatory that the demonstration should be conducted to the supplier's facility or warehouse, and that shall be witnessed jointly by PS and UP Manila;
- A bidder clarified the number of demo unit to be presented;
- Chairperson responded that 2 demo units are required, one (1) for demonstration and the other one (1) is a backup, in case of unit failure.
- PMO-in-Charge added that it could also be a hands-on unit and a demo unit;
- Bidders have objected the required quantity of demo units, requested if it could be decreased into one (1) demo unit only;
- The Chairperson asked the bidders one by one with regard to the objection and inform them that their request shall be deliberated, if granted, this will be reflected in the bid bulletin;
- Bidders requested to the body to bring sample slide specimen to be used during the presentation;
- The AdHOC Representative clarified that they shall bring a sample slides as requested;
- The Chairperson clarifies to the bidders that only one (1) demo unit is required and that samples shall be submitted to the supplier warehouse or at the Procurement Service, changes in the requirement shall reflect in the bid bulletin;
- Bidders clarifies the laptop unit that is included in the demo unit:
- PMO-in-Charge clarified the specification of the Laptop and that it has only standard specification;
- Bidder clarified the excitation filters requirement, the Blue Excitation Standard that ranges from 400mm to 490mm, requested to change the requirement to 460 – 490;
- Bidder clarified the Camera requirement, may be changed to "high definition or CCD camera (≥ 5MP)" from "high definition/CCD camera (>5MP);
- PMO-in-Charge told the bidders that all clarifications, if there's any, should be submitted within three (3) days.
