bulbs per Snellen Chart, the Chairperson suggested to put into writing their concern about this matter and the BAC will address the issue.

The Chairperson asked suppliers about the distance of 10 feet or 20 feet from the Snellen Chart, if there will be a difference in results, he asked to include this also in their letter as clarifications.

Item # 2: Eye Occluder

A bidder said that it would be too small to put the prescribed labelling, she suggested to put the labelling on the boxes instead. The Chairperson said to put into writing their query on this item.

Item # 3: Pinhole Occluder

A requirement that the material should be latex free. The Chairperson asked the Bidders if there is a testing center that can conduct such test, the bidders replied none. So the Chairperson said the bidder will be required during Post Qualification to submit a certification from the manufacturer that the items #2 and #3 are latex free.

Item #4: Diagnostic Set with Opthalmoscope, Fiber Optic Otoscope The Committee clarified the specs as follows:
