




Tri-Ex representative answered in the affirmative.</i> • <i>The Provisional Member stated that the PCAB License to be required for this Public Bidding shall be Small B.</i> • <i>The Provisional Member stated that a participating bidder will have to submit one original and two copies of their proposal.</i> • <i>The Chairperson advised the Tri-Ex representative to be observant of notices that will be posted on the PhilGEPS website.</i>
