> PhilGEPS Certificate BDS Clause 12.1 (a)(i)

The valid PhilGEPS Certificate of Registration (Platinum Membership) shall reflect the updated eligibility documents.

Should the Annex A of said Certificate reflects not updated documents, the bidder shall submit, together with the Certificate certified true copies of the updated documents.

The bidder shall submit a valid PhilGEPS Registration Certificate with its updated Annex A as part of Post-qualification documents.

HIGHLIGHTS OF ACTIVITY

> Statement of Single Largest Completed Contract BDS Clause 5.4

The Bidder must have completed, within the period specified in the Invitation to Bid and ITB Clause 12.1(a)(ii), a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC for Lot 1. Please Refer to Section VIII. Bidding Forms Annex "I" for the definition of similar contract.

As clarified by the Chairperson to the prospective bidder the similar contract shall not limit to the list provided in Annex "I".

The representative from Copy Data Systems Corporation requested to reduce the requirement to twenty five percent (25%) or aggregate contracts.

The Chairperson clarified to the prospective bidder that since the item fall within the non expendable item the default requirement is fifty percent (50%).
