The Chairperson explained that this number is just an internal reference number. • Representative from F1 Technologies asked if it is possible to also make an offer for Flash Drives that has no light indicator or only for Flash Drive with light indicators. The Chairperson clarified that what is reflected in the technical specification are the minimum requirements which must be met, offering outside the minimum requirements can lead to disqualification. • Representative from F1 Technologies also asked if they will only put the word comply or will they also indicate the specification of offer after the word complied. The Chairperson clarified that the prospective bidders will only cite the following: brand, model (if necessary), and statement of compliance.
