APPROVING THE PNP-UESB RESOLUTION NO. 2018-029 DATED MAY 22, 2018,
AMENDING NAPOLCOM RESOLUTION NO. 2013-286 THAT PRESCRIBED THE MINIMUM
STANDARD IN THE SPECIFICATIONS FOR GRENADE LAUNCHER CARTRIDGE 40MM,
HIGH EXPLOSIVE DUAL PURPOSE-LOW VELOCITY

WHEREAS, Section 14, paragraphs (i) and (m) of Republic Act No. 6975, as amended by Section 5, paragraph (a), sub-paragraphs (5) and (8) of the Republic Act No. 8551, empowers the Commission to “approve or modify plans and programs on education and training, logistical requirements, communications, records, information system, crime laboratory, crime prevention and crime reporting as well as prescribe minimum standards for arms, equipment and uniforms and, after consultation with the Philippine Heraldry Commission, for insignia of ranks, awards and medals of honor”;

WHEREAS, pursuant to the aforesaid legal prescription, the PNP favorably submitted the Uniform and Equipment Standardization Board (UESB) Resolution No. 2018-029 dated May 22, 2018, which proposed to amend NAPOLCOM Resolution No. 2013-286 that Prescribed the Minimum Standard in the Specifications for Grenade Launcher Cartridge 40mm, High Explosive Dual Purpose-Low Velocity, for consideration and approval by the Commission;

WHEREAS, the proposed amendment to NAPOLCOM Resolution No. 2013-286 focused on the “weight, color & marking and markings” requirements to correspond with the North Atlantic Treaty Organization (NATO) STANdardization AGreement (STANAG) 4402 as well as to adapt to the different colors and markings produced by different manufacturers;

WHEREAS, the PNP issued a certification that the subject proposed amendment is not exclusively patented to any commercial brand/model of product in the market;

WHEREAS, after thorough review and evaluation, the Commission finds the proposed amendment to NAPOLCOM Resolution No. 2013-286 that Prescribed the Minimum Standard in the Specifications for Grenade Launcher Cartridge 40mm, High Explosive Dual Purpose-Low Velocity, in conformity with the requirements of Republic Act No. 6975, as amended by Republic Act No. 8551, its Implementing Rules and Regulations (IRR) and all existing rules and regulations, to meet the requirements of the PNP;


NOW THEREFORE, the Commission, in the exercise of its constitutional power to administer and control the PNP, HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES, the PNP UESB Resolution No. 2018-029 dated May 22, 2018 amending NAPOLCOM Resolution No. 2013-286 that prescribed the Minimum Standard in the Specifications for Grenade Launcher Cartridge 40mm, High Explosive Dual Purpose-Low Velocity, with slight modification, to read as follows:

- I. Specifications:
- a. Nomenclature : Ctg. 40x46mm HEDP-LV
 - b. Weapon : 40mm (GL) series


- c. Projectile Type : High Explosives Dual Purpose
- d. Weight : 210-285 grams
- e. ~~Overall Length~~ : ~~102-106mm~~
- f. Filler Type : Comp A, A5, RDX or equivalent
- g. Fuze : Point Initiating Base Detonating (PIBD)
- h. Primer : Percussion
- i. Muzzle Velocity : 76 ± 5mps
- j. Arming Distance : 10-40 meters
- k. Color and Marking : Based on the Manufacturers Product Brand Specification Brochure, as Offered
- l. Markings : Based on the Manufacturers Product Brand Specification Brochure, as Offered


