PUBLIC BIDDING NO. 19-072-9

- 1. The Procurement Service, through the General Appropriation Act for 2017 intends to apply the sum of Ninety Eight Million Seven Hundred Eighty Seven Thousand Eight Hundred Pesos (Php 98,787,800.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Public Bidding No. 19-072-9: SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF NEW TWO (2) UNITS AIR PASSENGER BOARDING BRIDGES FOR THE SUBIC BAY INTERNATIONAL AIRPORT. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Procurement Service now invites bids for SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF NEW TWO (2) UNITS AIR PASSENGER BOARDING BRIDGES FOR THE SUBIC BAY INTERNATIONAL AIRPORT, in accordance with the attached drawings and technical specifications. The proposed, project shall include the provision of labor, materials, tools, equipment, application and securing of all permits and other incidentals necessary to complete the works for, but not limited to: clearing, removal and demolition works, SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF NEW TWO (2) UNITS AIR PASSENGER BOARDING BRIDGES FOR THE SUBIC BAY INTERNATIONAL AIRPORT. Completion of the Works is required by Three Hundred (300) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

- 7. Bids must be duly received by the BAC Secretariat at the address below on or before March 26, 2019; 10:00 AM All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on March 26, 2019; 10:00 AM at RR Road, Cristobal St., Paco, Manila, Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. Relevant Requirement: Minimum PCAB Category and Size Range;
 - License Category: A
 - At least Medium B size range for SP-EM (Electro Mechanical Work) specialty or at least Medium B size range for either SP-EE (Electrical Work) or SP-ME (Mechanical Work) but shall have SP-EE and SP-ME specialty if the bidder has no SP-EM specialty.
- 9. The *Procurement Service* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
