### **DESIGN AND CONSTRUCTION OF STORM DRAINAGE SYSTEM INCLUDING CONSTRUCTION OF WATER SUPPLY SYSTEM (Elevated Water Tank, Sump Tank, Inverter Pumps and Distribution Lines to the Building Facilities)**

#### **PUBLIC BIDDING NO. 19-271-5**

1. The **Basilan General Hospital** through the *Procurement Service*, through the *General Appropriations Act for FY 2017* intends to apply the sum of **Eight Million Two Hundred Forty Thousand Pesos (Php 8,240,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Design and Construction of Storm Drainage System including Construction of Water Supply System (Elevated Water Tank, Sump Tank, Inverter Pumps and Distribution Lines to the Building Facilities)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Procurement Service* now invites bids for:

**Bidders should have completed a contract similar to the Project equivalent to at least fifty (50%) of the ABC.** The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders. **For purposes of this project, similar contracts shall refer to any contract in both design and construction with a contract amount of at least.**

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

For the detailed evaluation of the design and build proposals a two-step procedure shall be adopted by the BAC. Only those bids that passed the technical proposals criteria shall be subjected to the second step of evaluation or the opening of financial proposals.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the *Procurement Service* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00PM., *Except Saturday, Sunday and Holidays*
