

INVITATION TO BID FOR THE

PROCUREMENT OF FUEL, OIL, AND LUBRICANTS FOR PROCUREMENT SERVICE-DEPARTMENT OF BUDGET AND MANAGEMENT FOR TWO (2) YEARS PUBLIC BIDDING NO. 010-2023

1. The PROCUREMENT SERVICE-DEPARTMENT OF BUDGET AND MANAGEMENT (PS-DBM), through the 2023 PS-DBM Revolving Fund, intends to apply the sum of Eleven Million Four Hundred Eighty-five Thousand Twenty-two Pesos and Sixty-four Centavos (₱11,485,022.64) being the Approved Budget for the Contract (ABC) to payments under the contract for the above project.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The **PS-DBM** now invites bids for the Procurement of Fuel, Oil, and Lubricants for PS-DBM for Two (2) Years. Delivery of the Goods is required within the delivery period stated in Section VI Schedule of Requirements of the Bidding Documents. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Prospective bidders may obtain further information from the PS-DBM and inspect the Bidding Documents through the Internal Bids and Awards Committee (IBAC) Secretariat at PS Complex, Cristobal St., Paco, Manila during *Mondays to Fridays, except holidays, from 8:00AM to 5:00PM*.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from the IBAC Secretariat upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amounts stated in Paragraph 1 of this IB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

It may also be downloaded free of charge from the websites of the PS-DBM and PhilGEPS, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The PS-DBM will hold a Pre-Bid Conference on <u>04 April 2023</u>; <u>01:30 P.M.</u> at PS Complex, Cristobal St., Paco, Manila which shall be open to prospective bidders.
- 7. Bids must be duly received by the IBAC Secretariat through manual submission at the office address indicated below on or before 20 April 2023; 01:30 P.M.

Late bids shall not be accepted. Unsealed or unmarked bid envelopes shall also be rejected.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on <u>20 April 2023; 01:30 P.M.</u> at PS Conference Room, PS Complex Cristobal St., Paco, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity in person or via Google Meet.

The PS-DBM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
