



INVITATION TO BID
FOR THE
SUPPLY AND DELIVERY OF STAPLE WIRE, STANDARD (26/6)
FOR THE PROCUREMENT SERVICE
PUBLIC BIDDING NO. 23-128-1

1. The *Procurement Service - Department of Budget and Management (PS-DBM)*, through the *PS Revolving Fund* intends to apply the sum of ₱33,554,790.00 being the total ABC to payments under the contract for Supply and Delivery of Staple Wire, Standard (26/6) for the Procurement Service. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *PS-DBM*, using a *multi-year* for a duration of *two (2) years Framework Agreement* pursuant to **Appendix 32 of the Implementing Rules and Regulation of RA9184 9th edition, Guidelines on the Use of Framework Agreement by All Procuring Entities**, through the *2023 PS Revolving Fund* intends to apply the ABC corresponding to the total cost of each item to be bid out, as follows:

2. The *PS-DBM* now invites bids for Supply and Delivery of Staple Wire, Standard (26/6). Delivery of the Goods is required within the delivery period as stated in Section VI Schedule of requirements of the Bidding Documents. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of

a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **PS-DBM** and inspect the Bidding Documents through the BAC Secretariat (Procurement Division V) at the address given below during *weekdays, except holidays, from 8:00AM to 5:00PM*.

A complete set of Bidding Documents may be acquired by interested Bidders on **November 14, 2023** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount indicated in the table below. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.

Late bids shall not be accepted. Unsealed or unmarked bid envelopes shall also be rejected.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **December 05, 2023; 10:00 AM**. at the given address below and/or via **Google Meet**, meet.google.com/fss-xqir-icf. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
