The **Procurement Service-Department of Budget and Management (PS-DBM)** through its **Bids and Awards Committee II (BAC-II)** invites interested bidders to submit proposals, with an Approved Budget for the Contract (ABC) in the amount of six hundred eighty-four thousand, seven hundred twenty pesos (₱684,720.00) for the procurement of the items stated below:

**Opening of the proposals shall be immediately after the deadline of submission.**

**Only one (1) set of original documents shall be required.** The envelope shall contain the name of the contract to be bid in capital letters and bear the name and address of the supplier in capital letters. Other documents required **shall be submitted manually** to BAC-II at Procurement Service, 2<sup>nd</sup> Floor Lobby on or before the deadline of submission as stated in this RFP.

**Unsealed or unmarked bid envelopes SHALL BE REJECTED.** However, bid envelopes that are not properly sealed and marked, as required, shall be accepted, provided that the bidder or its duly authorized representative shall acknowledge such condition of the bid as submitted.

In case of modification, it must be done before the deadline for the submission and receipt of proposals, and labeled as a "modification". The time stamped or indicated in the latest proposal received shall be the official time of submission.

The BAC-II shall assume no responsibility for the misplacement of the contents of the improperly sealed or marked bid, or submission of corrupted files, or for its premature opening. **Late submission of proposal shall not be accepted and considered.**
