Opening of the proposals shall be immediately after the deadline of submission.

Only one (1) set of documents certified to be true copies of the original shall be required. The envelope shall contain the name of the contract to be bid in capital letters and bear the name and address of the supplier in capital letters. Other documents required **shall be submitted manually** at 2nd Floor Lobby Procurement Service Building, Bids and Awards Committee II on or before the deadline of submission as stated in this RFP.

Unsealed or unmarked bid envelopes SHALL BE REJECTED. However, bid envelopes that are not properly sealed and marked, as required, shall be accepted, provided that the bidder or its duly authorized representative shall acknowledge such condition of the bid as submitted.

In case of modification, it must be done before the deadline for the submission and receipt of proposals, and labeled as a "modification". The time stamped or indicated in the latest proposal received shall be the official time of submission.

The BAC-II shall assume no responsibility for the misplacement of the contents of the improperly sealed or marked bid, or submission of corrupted files, or for its premature opening. **Late submission of proposal shall not be accepted and considered.**

5. *The supplier shall replace defective items, or refund payments made by PS-DBM for previously delivered items that were later found to be rampantly defective.*

EVIDENCE AND VERIFICATION

- **In-House Test:**
 - For general purpose cutter/utility knife
 - Determine the dimensions using a steel ruler:
 - Blade Measurements:
 - Length (± 2 mm): 100mm
 - Width (± 2 mm): 16mm
 - Thickness shall be determined using the Digital Vernier Caliper:
 - Blade Measurement:
 - Thickness: At least 0.40mm
 - Take one (1) blade and carefully snap off the top section. Remaining blade must not show any visible chipping nor breakage. Repeat up to the last section.
 - With a minimum of seven (7) snap-off blade sections to provide new sharp cutting points.
 - Workmanship:
 - Finish: With sharp cutting edges and free from rust and any matter that can affect serviceability.
 - Two (2) tubes with marking/labeling shall be provided by the bidder during the submission of additional post-qualification documents for verification of the product specifications.

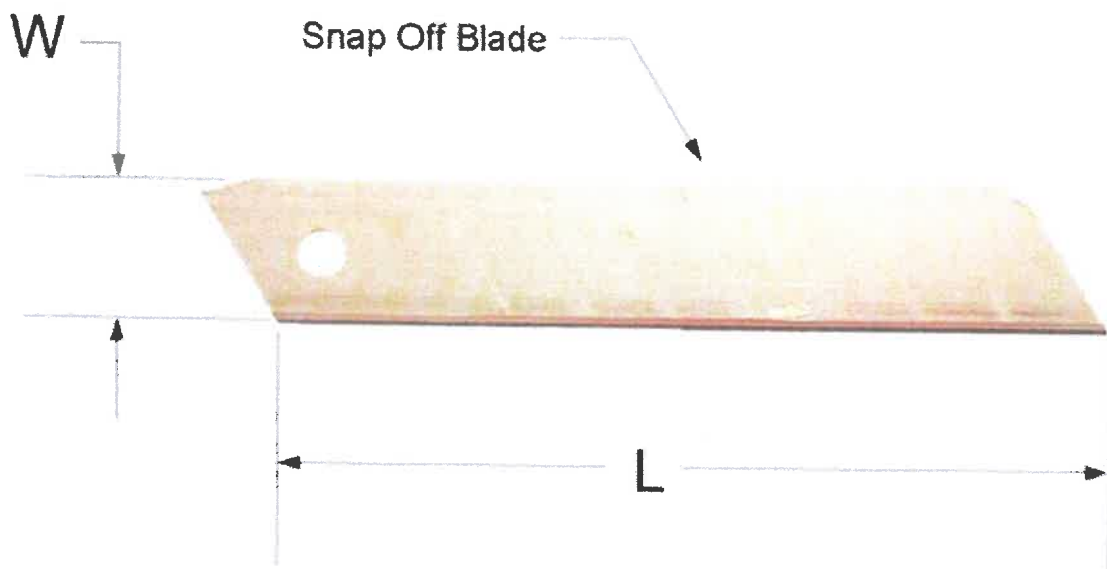
