No bid shall be considered unless accompanied by (10%) of the appraised value in the form of cash or cashier's/manager's checque. Late bids shall not be accepted. Bids will be opened in the presence of all the bidders or their duly designated representatives and the PS COA representative. Highest bidder shall pay the bid bond to the cashier after award. The bid bond of non-winning bidders shall be returned outright.

TERMS AND CONDITIONS

1. Sealed bids shall be dropped in the bid box located at the Office of the General Administrative and Servicing Division, 2nd floor, not later than 2:00 P.M., August 24, 2015.
2. Bidders are required to enclose a bid bond equivalent to ten percent (10%) of the bid price per lot in the form of cash, cashier's or manager's cheque acquired from a reputable bank.
3. A bidder may be allowed to withdraw his tender of offer before the date and time set for the opening of the bids and shall be returned to the bidder unopened.
4. All bids will be opened at 3:00 P.M. on the same day of bid submission in the presence of all the bidders or their duly designated representative/s at the Conference Room A, 2nd Floor, PS Complex, Cristobal St., Paco, Manila.
5. Awards shall be given to the highest bidder, provided the offer is not less than the appraised value of the equipment being sold. The bid bond of non - winning bidders shall be returned outright.
6. The ten percent (10%) bid price deposited by the awardee shall automatically be converted into partial payment for the lot bid, the balance of the offered bid price shall be paid within five (5) working days from the date of the notice of award, otherwise, the bid bond shall be forfeited in favor of the government.
7. The awardee has seven (7) working days to clear the area where the items are located from the receipt of the Notice of Award.
8. The PS Disposal Committee reserves the right to reject any or all bids, or any part thereof, waives any formality, requirements or defects contained therein and will accept the offer it considers most advantageous to the government.
