What is GOP-OMR?

- stands for Government of the Philippines-Official Merchants Registry
- a centralized electronic database for merchants registered with the PhilGEPS for purposes of government electronic procurement.

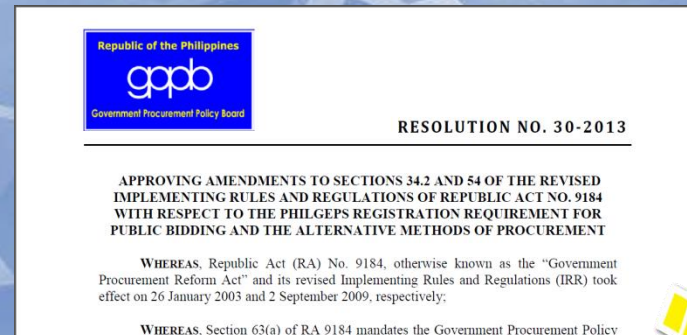


PhilGEPS Registration . . .

A new provision relative to the requirement of PhilGEPS Registration in Alternative Methods of Procurement under Section 54.6 of the IRR of RA 9184 as follows:

“Manufacturers, suppliers, distributors, contractors, and/or consultants are mandated to register with PhilGEPS and provide a **PhilGEPS Registration Number** in the following Alternative Methods of Procurement as condition for Award of Contract:

- Section 49 Limited Source Bidding
- Section 50 Direct Contracting
- Section 51 Repeat Order
- Section 52.1 (b) Shopping for Ordinary Office Supplies and Equipment not available in the PS
- Section 53.1 Two Failed Biddings
- Section 53.3 Take Over of Contracts
- Section 53.4 Adjacent and Contiguous
- Section 53.9 Small Value Procurement
- Section 53.10 Lease of Real Property
- Section 53.11 NGO Participation

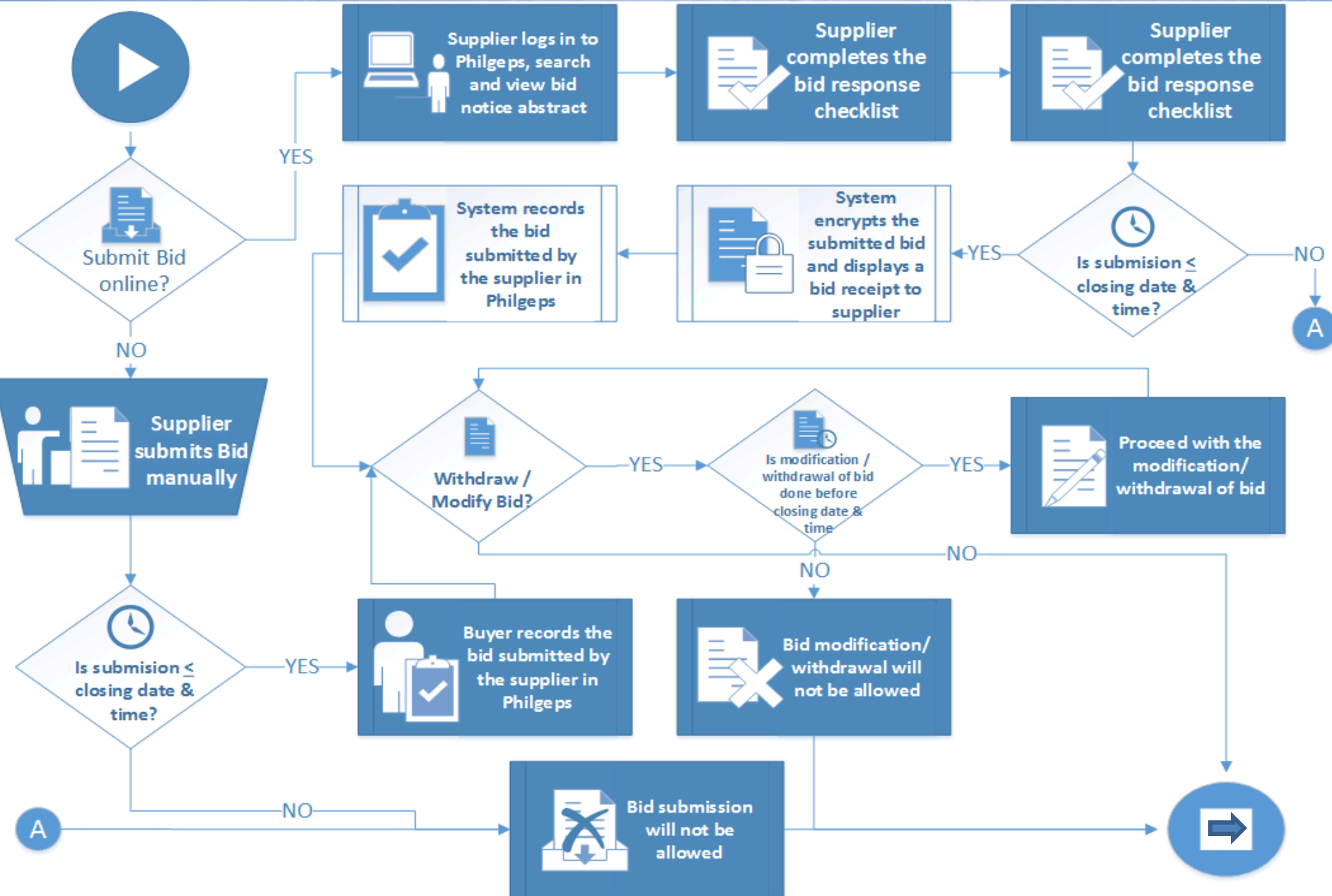

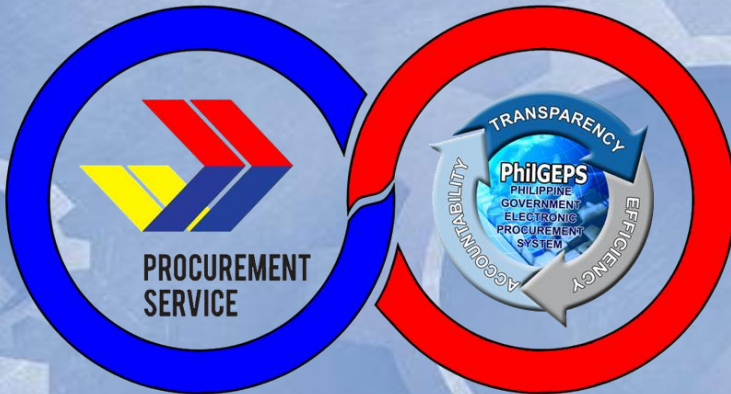
